Saguaro Chapter 68's fiscal year is July 1st –June 30th. All members receive Chapter 68's E-News and four issues of the WACVA National publication, *THE CHANNEL*.

1. REGULAR MEMBERSHIP—\$45 per year

- a. NOTE: For new Regular Members joining after January 1st, dues are \$22.50 and then \$45 per fiscal year thereafter, no matter when she renews.
- b. Women who are serving or have served honorably with the **United States Army, Army Reserves, Army National Guard, Women's Army Auxiliary Corps, Women's Army Corps or Army Nurse Corps.**

2. AFFILIATE MEMBERSHIP—\$30 per year

- a. NOTE: For new Affiliate Members joining after January 1st, dues are \$15 and then \$30.00 per fiscal year thereafter, no matter when she renews.
- b. Women who are serving or have served honorably with the **United States Air Force, Coast Guard, Marines, Navy or Space Force.**
